<b>W</b>	<b>Workshop or Seminar:</b> Professional workshops or seminars with acceptable sponsorship.
<b>C</b>	<b>Conference:</b> Professional meeting, conference or convention lasting one full day or longer. <i>(In addition to individual CE obtained at a Conference or Convention, an additional 3 hours per event may be claimed. <b><u>NO MORE</u></b> than 12 hours may be counted in this way per biennial period.)</i>
<b>H</b>	<b>Home Study:</b> Home study courses that have APA approved sponsors.
<b>GC</b>	<b>Graduate Class:</b> <i>(Calculated at 10 times the course credit granted upon successful completion.)</i>
<b>T</b>	<b>Graduate Class Preparation:</b> <i>(Calculated at 15 times the course credit, divided by the number of presenters. Subsequent teaching of the same course may not be counted again in future biennial periods.)</i>
<b>AGC</b>	<b>Auditing a Graduate Course:</b> <i>(Calculated at 5 times the course credit granted students.)</i>
<b>WP</b>	<b>Workshop Preparation:</b> <i>(Calculated at 4 times the course credit, divided by the number of presenters. Subsequent teaching of the same course may not be counted again in future biennial periods.)</i>
