Title 46, Part LXIII. Psychologists

RULE: Subpart I. Chapter 7 and Subpart 2. Chapter 33 (Supervision of Psychologists and Licensed Specialists in School Psychology)

RULE: Subpart I. Chapters 6. Fees

PUBLICATION SUMMARY and FINAL STATUS:

- Rule making was initiated to amend this Chapter in order to reinstate, eliminate and raise certain specific fees charged by the Board of Examiners of Psychologists in accordance with LA R.S 37:2354 and the Administrative Procedures Act §968 and 971.

- Final rule published June 20, 2017.


RULE: Subpart I. Chapter 13. Ethics

- Rule making was initiated to amend this Chapter, which specifically referenced the national (APA) code of conduct for psychologists, and promulgate each standard into the Louisiana Administrative Code. The amendment is in accordance with R.S. 37:2353 and R.S. 37:2359(B)(12).
